Non-emergency police. Highly recommended to use the online version of 311, PDXreporter.org, for most purposes as it is faster and creates a ticket record. Report illegal camping, piles of trash (both via the "Campsite Reporting" button), abandoned autos, graffiti, etc.

This program helps cover up graffiti. They will provide free do-it-yourself graffiti removal kits, including paint that (roughly) matches your area needing "buffed." Businesses with 10 or fewer employees, apartments or condos with 10 or fewer units, single family homes, and anyone impacted by hate or gang graffiti can request that the City come and remove the graffiti.

For businesses only, please. PEMO is a nimble office created by emergency order that has the goal of preventing environmental blight. It works on a system of responding to "tickets" brought to it by businesses and neighborhood associations, and it will do the work of connecting the relevant City departments and finding a solution. If there is an issue experiencing loitering, drug use, trash, or graffiti, for example, they might set up an on-site meeting with PPB, local business owners, trash services, and other relevant parties. They also help put up free string lights and connect with grants for murals and similar environmental improvements. PEMO has a standing Zoom meeting every two weeks (reach out to Grant Huling of SMILE for a link), or can respond to issues directly brought to them.
